## **Security of Cash**

- q** Each cash fund is accessible to only one person.
- q** Cash funds are kept locked except when authorized custodian is using it.
- q** Cash receiving and accounting duties are separated.
- q** Knowledge of safe combinations should be restricted, and combinations should be changed often, especially when turnover occurs.
